# Mole Valley Local Development Framework

Proposals to build in the Green Belt around the Bookhams were discussed. It was agreed to object strongly as follows:

BK05 (Guildford Road): diminution of the green gap along the A246; support for the idea of a village green; infrastructure (schools, health service, roads) already overloaded.

BK06 (Woodlands Road): this represents an extension to the built up area of Effingham; diminution of green gaps between settlements; greater flooding likely to be caused by reduced permeability in this area; infrastructure overloaded as before; sewer capacity will not cope.

# Reports and correspondence relating to other Planning matters:

<u>Elmbridge Borough Council's Core Strategy – proposed submission to Secretary of State</u> Cllr Lightfoot had read this and reported it was a good document; no concerns for Effingham.

#### Wisley 'airfield'

The planning application for a composting unit had gained approval. An access road from the A3 / Ockham roundabout is to be built, which it is feared will provide the opening for more developments.

## Further HGV O-licence application at Newmarsh Farm

The Clerk reported that a Chessington-based demolition firm with an existing licence for a vehicle at Newmarsh Farm had applied to have its address re-registered at Newmarsh. The Parish Council had written, as to all previous applications, concerning the establishment of this site without due process. GBC is now collating a diagram of where existing licence holders say their pitch is, so that usage of space and number of applications can be monitored.

## Spinney Copse, Outdowns

An unauthorised access had been created directly onto the A246. Both Highways and GBC Planning had acted with alacrity and to outward appearance the access has been closed up again.

#### Joint Communities Group

The Clerk had attended another meeting, at which a senior GBC Planner had explained his approach to two recent retrospective planning applications for Gypsy and Traveller settlements in Ripley.

#### Planning applications, Home Farm Estate

Cllr Nicholls reported he was aware of three residents who were unable to proceed with their plans for development because of planning constraints, which he felt were acting unfairly to hamper improvement of the area.

# Mowing in front of the shops

Mr Gibb had indicated he would soon be hoping to hand over this job to someone else. There was discussion about who to approach, on a commercial or more voluntary basis. It was agreed to include this in the 'brainstorm' in April because it applied not only to this area.

# Howard of Effingham - Foundation Status

The Clerk reported that the school believes it fully advertised the advertisement of the consultation result. The meeting with the governors was confirmed for 2.30 on 29 March. Councillors will meet beforehand to brief themselves.

## Proposed extension of all weather surface, KGV Playing Fields

Cllr Nicholls reported that the School had mentioned proposals for this were being discussed with EVRT, which Cllr Jones confirmed. The proposed area appeared to be much larger than the current, and potentially to affect the woodland. Cllr Nicholls regretted this would mean the extension of more ball games in the area, but nothing for the disabled or young or elderly users. Cllr Hogger felt there

needed to be a wider understanding of the issue; what was the School intending to do with its own land where this facility had been first proposed? Possibly the School was unaware of the potential community reaction, as with the idea of closing the footpath.

## Beech Avenue verges

Cllr Wetenhall reported that the clearance and replanting had continued, and some areas looked shockingly bare. Pressure would have to be put on to tidy up the site. Residents would possibly help with a litter pick.

#### 44.10 HIGHWAYS AND TRANSPORT

#### **Current Highways and Transport matters**

## M25 Draft Orders

These only affected the M25 carriageway area, not the service station. There was no need to comment.

## Dirtham Lane

The Local Committee had voted for the 30mph limit along Dirtham Lane and through the woods, having been given no other option. It was agreed to write formally asking for a Traffic Regulation Order, and to try to gain the support of Sue Sturgeon at GBC.

#### **EVRT**

Cllr Jones reported that the new Trustee's responsibility will be funding and future financial planning. Mike Summers' role has been restructured. He will continue the book-keeping. Over 100 responses to the questionnaire had been received. The Executive Committee will analyse the responses and will share the results with EPC. The User Group Committee had three elected positions of which two had been filled, by Nigel Maycock Chairman of the Rugby Club, and Paul Grant of the Rugby Club. Cllr Nicholls objected to the over-representation of the Rugby Club. Cllr Jones said these people had taken the opportunity to stand for election where others had not. They had no decision-making powers. The opportunity to stand for election had been well publicised in the village.

The re-roofing project had been completed and had cost £70k.

There will be a Board of Trustees meeting next week. Cllr Hogger asked when the Trustees would be ready to talk to the EPC sub-group about future funding and the service level agreement (or similar) as this was becoming pressing. Cllr Jones said he would raise this with the Trustees.

Cllr Nicholls described a disagreement about use of the pitch after heavy rain, when the surface was badly damaged. There was a discussion about whether the appropriate person was making the decision to play / not play for the sake of a village amenity.
